The Sumner County Board of Education, herein known as "School System", is soliciting bids for the construction of a pavilion at Portland Gateview Elementary. The bid is to include materials and labor.

- x Shall provide and obtain all necessary materials, equipment and labor.
- x Shall provide and obtain all necessary permits with Local, County, etc. agencies as required by law.
- x Shall schedule all necessary inspections with Local, County, etc. agencies as required by law.
- x Shall strictly adhere to engineered drawings. The School System reserves the right to withhold partial or all payment until the work is completed to the specifications and satisfaction of the School System. Any work not completed to specifications will be the Contractor's sole responsibility and expense to redo.
- x Shall provide Worker's Compensation Insurance as required by Tennessee State Law. The Contractor shall prove compliance with Public Chapter No. 587, T.C.A. 49-5-413(d), criminal background check, and provide a Drug Free Workplace Affidavit.
- x Shall dispose of all generated waste materials in compliance with all Local, State and Federal guidelines, regulations, and requirements.
- x Shall have properly trained and experienced staff to facilitate the specified services.

### Scope of Work:

The vendor is to submit pricing for the construction of a 48' x 60' pavilion. The structure is to consist of a wood frame, metal roof, closed in ceiling (See Sample "B"), and concrete floor (4,000psi). Included with the specifications are a sample photograph, post location diagram, and sample materials list. The structure must be constructed to match the layout and look of the sample photograph (Sample "A" and "B"). In order to provide sufficient structure stability, the post location diagram (Sample "C") must be strictly adhered to. The sample materials list (Sample "D") was generated as a guide for necessary materials. The vendor must submit a materials list with the bid for review.
